

God's Holy Word the Bible

Introduction:

According to the scriptures, for example in Matthew 7:13, and Matthew 13:27-30, the Holy Bible declares how professing believers can expect that there will be a number in every fellowship group who for God's own purposes will demonstrate to be in need of learning whether or not they believe with the whole heart that God has kept His promise with respect to His Holy Word to them.

In any fellowship group where sinners reside, and, where by default, consensus must exist, there will be an often indiscernible mixture of faith and doubt (Ecclesiastes 1:9). Subsequently, 'no congregation of souls' on the face of the sin cursed earth, and as a whole, may manifest God's perfect people Israel in the eternal spiritual sense. In many ways the bible declares that the tares are going to grow up with the wheat until the harvest which is the end of the world (Matthew 13:30).

God's Holy Word the Bible never shows a world where every soul is saved from their sins. From Matthew 7:13, God is clear how most of the world, which is manifested through groups, fellowships, and churches, will not most, be of God's elect. Subsequently, His merciful warning goes out to all of mankind:

Matthew 7:13-14 Enter ye in at the strait gate: for wide is the gate, and broad is the way, that leadeth to destruction, and many there be which go in thereat. 14 Because strait is the gate, and narrow is the way, which leadeth unto life, and few there be that find it.

The bible declares that God's eternal people 'Israel' are scattered about the earth in every nation as lost sheep that shall be found.

Deuteronomy 30:3 That then the LORD thy God will turn thy captivity, and have compassion upon thee, and will return and gather thee from all the nations, whither the LORD thy God hath scattered thee.

The hardened wicked and the fool who say in their outward behavior, 'there is no God', (Psalm 14:1), must fight against, and resist God's Holy Word the Bible. Today, in the churches, the way they can be seen doing this is by ignoring and dismissing God's precepts and commandments. This is because it is God's precepts and commandments, [spiritual things], that would confine the gain sayer so that they are not be able to do their own good pleasure as God demonstrates for example in Genesis 11:4.

Genesis 11:4 And they said, Go to, let us build us a city and a tower, whose top may reach unto heaven; and let us make us a name, lest we be scattered abroad upon the face of the whole earth.

In Matthew 13:27-30, God explains how a spiritual doubling manifesting, 'good', and 'evil', must go forward from the Garden of Eden. It begins with Cain who killed His brother Abel. Abel must have manifested a soul that was of God's chosen elect which must have tormented Cain's ears (Acts 7:54-60).

Through the comparing of God's Holy Word the Bible, as the spirit of truth guides, God explains this further in Matthew 13:27-30:

Matthew 13:27-30 So the servants of the householder came and said unto him, Sir, didst not thou sow good seed in thy field? from whence then hath it tares? 28 He said unto them, An enemy hath done this. The servants said unto him, Wilt thou then that we go and gather them up? 29 But he said, Nay; lest while ye gather up the tares, ye root up also the wheat with them. 30 Let both grow together until the harvest: and in the time of harvest I will say to the reapers, Gather ye together first the tares, and bind them in bundles to burn them: but gather the wheat into my barn.

The bible indicates that God's people can know that what is being said above in Matthew 13:27-30 ultimately is the result of mankind's sin in the Garden of Eden in the first Adam (1Corinthians 15:22). In Genesis 3:10, and 4:6, the Lord further reveals the sinful nature of all of mankind from the very beginning.

Genesis 3:10 And he said, I heard thy voice in the garden, and I was afraid, because I was naked; and I hid myself. 11 ¶ And he said, Who told thee that thou wast naked? Hast thou eaten of the tree, whereof I commanded thee that thou shouldest not eat?

Genesis 4:6 ¶ And the LORD said unto Cain, Why art thou wroth? and why is thy countenance fallen? 8 ¶ And Cain talked with Abel his brother: and it came to pass, when they were in the field, that Cain rose up against Abel his brother, and slew him. 9 ¶ And the LORD said unto Cain, Where is Abel thy brother? And he said, I know not: Am I my brother's keeper?

Following the disobedience of Adam and Eve, when in Adam all of mankind chose to obey the serpent instead of God's Holy Word, (1Corinthians 15:22), this is where all sinners ultimately come from, except individually they shall find themselves in the spirit of Christ, according to God's Holy Word the Bible.

As God's Holy Word the Bible declares, one thing the born again elect can know, where as once they were blind now they see (John 9:25). Through the love that the Father and the Son has bestowed upon them, in an eternal spiritual sense, they must be rejected by this world which the devil rules as the anti-christ; yet, from before the foundation of the world, or time began, Christ, for His elects sake, has destroyed the works of the devil.

1 John 3:1, 5, 7-8, ¶ Behold, what manner of love the Father hath bestowed upon us, that we should be called the sons of God: therefore the world knoweth us not, because it knew him not. 5 And ye know that he was manifested to take away our sins; and in him is no sin. 7 Little children, let no man deceive you: he that doeth righteousness is righteous, even as he is righteous. 8 He that committeth sin is of the devil; for the devil sinneth from the beginning. For this purpose the Son of God was manifested, that he might destroy the works of the devil.

On this sin cursed earth God's truth was manifested through God's chosen Holy men of old, who had become Jews inwardly and not outwardly, and in whom the spirit of truth caused to recognize God's warning of pending judgment on those who do not keep God's Holy Word. This was how God would establish the early church, [where two or three are gathered in His Name], as the Apostle Paul declared:

2 Corinthians 11:12 But what I do, that I will do, that I may cut off occasion from them which desire occasion; that wherein they glory, they may be found even as we. 13 For such are false apostles, deceitful workers, transforming themselves into the apostles of Christ. 14 And no marvel; for Satan himself is transformed into an angel of light. 15 Therefore it is no great thing

if his ministers also be transformed as the ministers of righteousness; whose end shall be according to their works.

God's root doubling found throughout the gospel of His Son perpetually demonstrating, 'good', and 'evil', from the Garden of Eden on, shall be experienced by all of mankind, as thorns and thistles, and eating of bread by the sweat of ones brow, through (1) error, and (2) reproofs of instruction as a way of life, but only His elect have had their sins paid for.

2 Timothy 3:5-7 Having a form of godliness, but denying the power thereof: from such turn away. 6 For of this sort are they which creep into houses, and lead captive silly women laden with sins, led away with divers lusts, 7 Ever learning, and never able to come to the knowledge of the truth.

As part of the great tribulation, which is now showing may have begun in 1948 A.D., and according to God's gospel design, many have been lead to one of two original texts of God's Holy Word the Bible. A division between these original texts has been proving to be the cause of the separations that exists between those who seek to obey God's Holy Word the Bible, and those who seek modern translations as a means of coming closer to Christ [by works of their own hands]. What remains to be a fact is how these modern translations have 'not' shown to lead to more obedience, but rather to more disobedience (Revelations 22:18-19).

There was a man who was considered by many to have been one of God's elect. His name was Harold Camping. He was the founder and president of Family Radio Inc., from approximately 1959 to 2013. For many, this man continually showed to be indwelt by the spirit of truth according to the scriptures. On his talk show, 'the Open Forum', Harold shared his belief with respect to a biblical conclusion God had given him for an answer to the on-going questions about God's inerrant and infallible word the bible. Harold's conclusion to his listeners was that all a true believer would ever need in their exceeding short life span in order to learn God's truth's was the King James Bible, and the Strong's or Young's Concordance. This was simultaneously under the condition that they would also be of those who would show to be of God's born again elect.

Computers did not exist at this time as we presently know them, yet for hundreds of years, and according to God's will and good pleasure, God's children were experiencing no hindrances with respect to the spiritual joy they found in God's infallible word, whether it be the Geneva bible or the 1611 King James, or the later 1769 King James. The fact is, it can be proven without a reasonable doubt that America's spiritual foundation was based on these translations of God's Holy Word the Bible. And throughout the process of America's first beginnings, it can also be known that most of the early God fearing American's knew nothing about Greek and Hebrew as the 'so called' only true means of perceiving and understanding God's Holy Word. God alone had done the work that was necessary for His chosen elect where-ever they would be found throughout the world, to hear His Holy Word in their own language.

According to all of scripture, it is the leaders responsibility to ensure their nations people come to hear God's Holy Word. Infinite God who is without beginning and who is without end in everything He does shall perfectly hold the world accountable for what God has shown the

world is true, (Romans 1:17-20), whether they look at His word or not. God is not obligated to show mercy to any that is not according to His will and good pleasure as was finished before the world began.

Additionally, the issue here is not that computers necessarily represent that which is evil. Rather like the different original texts that can be seen today through the advancement of computers, and the legion of concordance web sites, computers must end up representing the same disharmony that is found throughout the world where both the wheat and the tares reside together. However, the computer can now spread the gospel of the anti-christ with greater speed and coverage, which ought to be expected as the world shows to be so close to its end.

So suffice to say, it is not the speed or greatness in coverage computers manifest that is of any eternal spiritual benefit to God's people. Actually speed and coverage has everything to do with a time line that must come to an eternal end – but woe unto those who caused Christ's truths to become unfruitful. Even many of the corporate church's of our day understand that a quick comparison of the different Bible's shows all bible versions are not nearly the same.

Some leave out entire verses, others disagree on whether Jesus should be called God's servant or God's Son. But more significantly, it would appear these differences stem from copies of the original text that can be seen by one group as being accurate, while other copies of the original languages will be seen by another group as accurate when only one can be accurate. This is because the two copies, both which are considered the original text, yet, do not agree with one another. So how does one come to understand which is correct?

The specialists want to excite you, in place of the spirit of truth, so they make truth look complicated, and themselves alone as the ones who can simplify it for you. But the biblical truth is, "we cannot be right with God based on what we know, except our sins have been paid for before any of us were born". If we think that what we understand from God's word is what makes us eternally right with God, we show to have a 'works gospel' that will not save anyone who is under the hearing of it. The Apostle Paul of the early Christian church, and by the spirit of truth, was caused to understand this. 1 Corinthians 8:1-3 is one example God gives through His Holy men of old.

1 Corinthians 8:1-3 ¶ Now as touching things offered unto idols, we know that we all have knowledge. Knowledge puffeth up, but charity edifieth. 2 And if any man think that he knoweth any thing, he knoweth nothing yet as he ought to know. 3 But if any man love God, the same is known of him.

One of the ways this spiritual warfare works its way out today is that it manifests those who show to be content with the sufficiency God has provided them, contrast those who must continually seek something new and exciting as a replacement for the Comforter who is not present. The bottom line, [according to God's will and good pleasure], is that there are two different texts of the original languages from which Bibles are translated, and only one can be correct. And choosing the right one is not the authority of Greek and Hebrew scholars.

Today while it is called day God does not present a choice to His people with respect to which Greek and Hebrew is the most accurate. God has already provided the world with His will and good pleasure God's Holy Word the Bible:

God's Holy Word the Bible has a lot to say about Christ and His bride. God does not look at everything about His faithful, [elect], with suspect, so that He can't receive her wholly. Because Holy God has purchased her and forgiven her for her sins, she is wholly pure in His eyes, though God shall simultaneously workout His relationship with her on the sin cursed earth through chastisement and correction. This is because of what God alone accomplished before the world or time began with respect to His Elect Bride.

This is how God teaches His people through the Comforter through God's Holy Word the Bible. They can trust God that He has provided them that which is wholly acceptable and true as witnessed through the spirit of Christ in His heavenly Father who is abiding in His elect. Subsequently, it is not the inanimate book we call the bible, alone, that is most critical, but the spirit of truth who guides His faithful through God's Holy Word the Bible, that is making that which was dead come to life – according to God's Holy Word the Bible.

It is in this context, and from season to season, God's people through the Comforter can see when error is taking place. These errors can manifest as words, and phrases, and whole sentences, that were seen as God's Holy Word, being removed from later translations. This is 'not' a sign from the Holy Ghost with respect to that which is 'good', but rather with respect to that which is 'evil'. This is 'not' showing how an original text is bringing God's Holy Word the Bible more accurately when Revelations 22:18-19 is being violated.

God's people will follow God's revealed will and good pleasure. The world cannot, and will not. Instead, in various ways and methods, they will try to destroy the witness of God's Holy Word the Bible through change over long, and then shorter periods of time. For those who may be interested in a basic explanation with respect to this particular problem, the discussion continues.

Accurate Copies:

These manuscripts represent the manuscripts from which the "**Textus Receptus**" or **Received Text** was taken. They are the majority of Greek manuscripts which agree with each other and have been accepted by Bible believing Christians down through the centuries. It is from these manuscripts that the King James Bible was translated in 1611.

Corrupted Copies:

These manuscripts represent the corrupted copies of the Bible, also known as **the Alexandrian manuscripts**. These manuscripts, many times, do not even agree with each other. The **Vaticanus** and **Sinaiticus** manuscripts are part of this group. These are the manuscripts on which Westcott and Hort and the modern versions rely so heavily.

There are 5,309 surviving Greek manuscripts that contain all or part of the New Testament. These manuscripts agree together 95% of the time. The other 5% account for the differences between the King James and the modern versions.

The modern versions had to use the Textus Receptus, since it contains the majority of the surviving Greek manuscripts. **The problem is** that, when the Textus Receptus disagreed with the Vaticanus or the Sinaiticus, they preferred these corrupted manuscripts over the Textus Receptus. That accounts for the 5% corruption in the modern versions.

Even these two manuscripts, [Vaticanus and Sinaiticus], agree with the Textus Receptus much of the time. When they do not agree, it is because Marcion (120-160 AD) or Origen Adamantius, (184-254 AD), or whoever, corrupted them. Evidently, Marcion was simply another who did not understand the spiritual harmony between the Old and New Testaments, and is said to have created a dual-deity in his theology ultimately separating Christ as a person from His Father as a person. Origen, on the other hand, was simply another who believed redemption would come to every soul, perhaps even including the devil, and was considered, anathema, [cursed].

Now, the fact has been established that the modern versions are different than the King James Bible. But, we still need to answer the question: Why are they different, and how can this difference affect one's ability to properly correct the few weaknesses that may be found in the King James – though technically most are really not weaknesses – that a born again elect who is indwelt by the spirit of truth cannot see through without the study of Greek and Hebrew? Consider this too: if every word in the King James bible should become suspect so that a bible student spends most of their study analyzing words, instead of reading the bible, “what is happening to God's word? And is it ‘not’ under attack?” The Holy Bible says in 2 Corinthians 5:7 the child of God “walks by faith not by sight” – not by doubt.

It has been shown how there are at least 5,309 surviving Greek manuscripts which contain all or part of the New Testament. Plus, there are translations into different languages which date back to within 100 years of the disciples. For example, **the Peshitta**, [meaning ‘simple’, ‘easy to be understood’], {which immediately should throw up a red flag}, is a Syrian translation from the 2nd century sometimes called the **Syriac Vulgate**. These manuscripts agree with each other about 95% of the time. **The problem is**, how does one determine ‘what is true’ in the 5% of the places where the manuscripts do not agree?

Argument One:

Modern version view: "The Bible is just like any other book. It is not liable to Satanic attack. In order to find out what the original copy probably said, you just find the oldest copies available and use them. "We don't have the exact word of God now anyway, so a few disagreements will not matter."

Argument Two:

King James Bible view: "The Bible is not ‘just like any other book.’ Satan hates it because it is the Word of God. The Devil has been trying to destroy the truth of God's word since the Garden of Eden.

However, God has preserved His Word for us. He preserved the Old Testament through the Levites as priests and He has preserved the New Testament through the body of believers

through the witness of the Holy Spirit. The vast majority of Greek manuscripts agree together. They have been passed down through the centuries by true Bible-believing Christians who were lead by the spirit of truth that indwelt them.

For example, in 1516 Erasmus compiled, edited, and printed the Greek "Textus Receptus" [Received text]. This is the text that the Protestants of the Reformation knew to be the Word of God (inerrant and infallible). The King James Bible was translated from the "Textus Receptus."

Argument One Continued:

Modern version view: The oldest surviving manuscripts must be the most reliable. Therefore, when determining what manuscripts to depend on, the Vaticanus (350 AD) and the Sinaiticus (about 350 AD) should be accepted as correct (even if 998 other manuscripts disagree with them).

Argument Two Continued:

King James view: The oldest manuscripts (the Vaticanus and Sinaiticus) are not reliable at all! Further, the Vaticanus and Sinaiticus disagree with each other over 3,000 times in the gospels alone!

Facts About the Vaticanus

It was written on fine vellum (tanned animal skins) and remains in excellent condition. It was found in the Vatican Library in 1481 AD. In spite of being in excellent condition, it omits:

Genesis 1:1 through Genesis 46:28

Psalms 106-138

Matthew 16:2-3

The Pauline Pastoral Epistles

Hebrews 9:14-13:25

Revelation

Besides all that, in the gospels alone it leaves out 237 words, 452 clauses and 748 whole sentences, **which hundreds of later copies agree together** as having the same words in the same places, the same clauses in the same places and the same sentences in the same places. Further, the Vaticanus was available to the translators of the King James Bible, but they didn't use it because they knew it is unreliable. The Vaticanus also contains the Apocrypha [today's Catholic bible].

Facts About the Codex Sinaiticus:

The Sinaiticus is a manuscript that was found in 1844 in a trash pile in St. Catherine's Monastery near Mt. Sinai, by a man named Mr. Tischendorf. It contains nearly all of the New Testament plus it adds the "Shepherd of Hermes" and the "Epistle of Barnabas" to the New Testament.

The Sinaiticus is extremely unreliable, which is proven by examining the manuscript itself. John Burgeon spent years examining every available manuscript of the New Testament. He writes about the Sinaiticus: "On many occasions 10, 20, 30, 40 words are dropped through very carelessness."

Letters, words or even whole sentences are frequently written twice over, or begun and immediately canceled; this gross blunder, whereby a clause is omitted because it happens to end in the same words as the clause preceding it, occurs no less than 115 times in the New Testament."

That's not all:

On nearly every page of the manuscript there are corrections and revisions, done by 10 different people. Some of these corrections were made about the same time that it was copied, but most of them were made in the 6th or 7th century.

Phillip Mauro was a brilliant lawyer who was admitted to the bar of the Supreme Court in April 1892. He wrote a book called "**Which Version**" in the early 1900's. He writes concerning the Sinaiticus:

"From these facts, therefore, we deduce: first that the impurity of the **Codex Sinaiticus**, in every part of it, was fully recognized by those who were best acquainted with it, and that from the very beginning until the time when it was finally cast aside as worthless for any practical purpose."

The accuracy of God's eternal word is never measured according to time:

The Vaticanus and Sinaiticus manuscripts are the oldest, but they are not the best manuscripts! That's where the modern translators went wrong! They foolishly accepted the Vaticanus and Sinaiticus simply because they were old.

They did not attempt to find out why they were so vastly different from the Greek text that many Christians have known to be the infallible Word of God.

Don't fall for the "oldest are the best" line! The oldest are not the best! For example, the Vaticanus and Sinaiticus both leave out the last 12 verses of Mark, concerning the resurrection of Christ. But, there is not one other manuscript, either uncial, [written entirely in capital letters], or cursive, [connected characters], that leave out this passage. There are 18 other uncial (capital letter) manuscripts that have the passage in and at least 600 cursives (small letter) manuscripts that all contain these verses.

The evidence is at least 618 to 2 against the Vaticanus and Sinaiticus:

Yet, look in your modern version. The New American Standard Bible puts all these verses (Mark 16:9-20) in brackets, saying that these verses probably were not in the original writings. The other versions use brackets or footnotes.

That's ridiculous! In a court of law, if you had 618 witnesses that saw something happen, and you had two witnesses that said they did not see it happen, would you accept the testimony of the 618 or the testimony of the 2?

You see, it is foolish for any translator to accept a manuscript simply because of age, or any other reason, without checking to find out where it came from and if it has proven to be reliable or not. Further, why do the modern versions, that come from these proven corrupted copies, question the virgin birth of Christ, attack the doctrine of the deity of Christ, the infallibility of the Bible, the doctrine of salvation by faith, and the Trinity? The bible alone and in its entirety give the answer:

Genesis 3:1 ¶ Now the serpent was more subtil than any beast of the field which the LORD God had made. And he said unto the woman, Yea, hath God said, Ye shall not eat of every tree of the garden?

Speaking for myself with respect to my own spiritual comfort, and by God's sufficient Grace, I've come to understand that the King James come from the most trusted copies of the original language that can be found on earth – as God has promised. The Strong's and Young's concordances are, 'word for word', linked to the King James Translation. In fact, they are "the bible" in an analog computer generated form. And, for any who may be interested: the 'Power Bible' software, is the Strong's concordance on CD, and which does not require one to be on-line in order to use it. I am very content with what God has given me on this sin cursed earth with respect to His Holy Word the Bible.

Those who will reject and ignore God's warning about the devil who seeks to remove God's word from them must finally demonstrate to be those who God is speaking of in the following:

2 Thessalonians 2:11 And for this cause God shall send them strong delusion, that they should believe a lie:

2 Timothy 4:3 For the time will come when they will not endure sound doctrine; but after their own lusts shall they heap to themselves teachers, having itching ears;

It is God's commandment from His Holy Word the Bible that we learn, and that gave America the strength she continues to possess. So we are either going to be seen as those who are all the more obedient to God's Holy Word the Bible, or we are going to be seen as those who must prove beyond our own reasonable doubt that God's word is really saying what it says, as many dissect the original text while God continues to hold all English people accountable:

Titus 2:1 ¶ But speak thou the things which become sound doctrine:

2 John 1:9 Whosoever transgresseth, and abideth not in the doctrine of Christ, hath not God. He that abideth in the doctrine of Christ, he hath both the Father and the Son.
